

Anti-Bribery and Corruption Policy

Alraiedah Underwater LTD is committed to conducting its business with the highest standards of ethics, integrity, and transparency. As part of this commitment, we maintain a strict zero-tolerance policy towards bribery and corruption in all aspects of our operations. This policy outlines our stance against bribery and corruption and establishes guidelines for ethical conduct that all employees must adhere to.

Scope:

This policy applies to all employees of Alraiedah Underwater LTD, including full-time, part-time, temporary, and contract workers. It encompasses all business activities conducted by the company, both domestically and internationally.

Policy Statement:

- 4) **Training and Awareness:** Alraiedah Underwater LTD will provide regular training and awareness programs to ensure that all employees understand their obligations under this policy and are equipped to identify and report instances of bribery and corruption.
- 5) **Monitoring and Review:** This policy will be periodically reviewed and updated as necessary to ensure its effectiveness and alignment with legal and regulatory requirements. Any changes to the policy will be communicated to all employees in a timely manner.
